Summary of replies: Andrew Turner: Questions asked of ophthalmologists by GRCVIC need to be addressed by their national group. Robin Stanley: No reply except a delay in response email due to COVID 19 Chloe: Addressed retinol folds vs MRD – if a puppy has retinol folds but not evident after 12 months of age it is not classed as MRD but normal. If retinal folds present after 12 months of age it is classed as MRD. Glaucoma – Well known as a problem in golden retrievers, inheritance isn't known. No idea of numbers being diagnosed or the split of diagnosis between registered and unregistered golden retrievers. ? lack of statistics on number of effected individuals. Have an issue with it being stated as a problem in the breed but no evidence to support this. SA: Very concerned about asking breeders to test for glaucoma when there is no consensus amongst ophthalmologists and no statistics provided on the glaucoma. ACES ophthalmologists in other states not in agreement that it is an issue. Important to see what information comes out of the UK regarding glaucoma and the study they are doing. NSW: Received an email from a previous panellist, suggesting that the breed council needs to collect information across all states to decide on whether it is an issue in the breed. Looking at getting some talks from a few specialists in the next few months. 	All clubs to look at eye testing issues and how this is best dealt with for the best outcome for the breed.
